Location: Streamleaze Play Area, Thornbury

Severity (S): The following risk assessment has been prepared to consider the risk of transmission of the COVID-19 virus only. It is assumed that all other safety issues are managed separately. As a consequence, the Severity (S) rating of transmission of the virus is a constant and is based upon the recipient or someone that they subsequently infect (indirect risk), requiring hospital treatment (3 out of 5).

Possible Likelihood (L): 5 (Highly likely), 4 (Likely), 3 (Possible), 2 (Unlikely), 1 (Highly unlikely)

					<p>Promote feedback and incident reporting. Removal of some items of equipment which will help users to socially distance. Swings – where there are two swing seats in place in a standard bay, we will leave only one seat in use in each bay. We will leave at least one flat seat and one cradle seat in each play area. Basket swings – these are being removed. Although they are a fully accessible item, we know our basket swings are more likely to be used by multiple children at the same time and therefore this risk is considered to outweigh the benefits of keeping the equipment in use. No other fully accessible equipment is being removed. Signs to advise limiting the number of family members accompanying children in the play area. It was felt to be not reasonably practicable to undertake frequent disinfecting during the days of use and will not significantly reduce the risk due to unknown levels of use. These are outdoor sites so the virus will not stay active as long as it would for indoor play areas.</p>

						<p>Propping open or removal of the gate into the play area was considered but it was noted that the surrounding green area is a popular dog walking area and the risk of dogs off leads getting into the play area was greater than the risk associated with use of the gate latch, particularly if the correct signage is in place.</p> <p>Prevention of use of seats was felt to be unnecessary if correct advisory signage is in place.</p>
