It was also noted that the CIL programme would also be considered by the working group and at the Finance and Policy Committee meeting on 19 December 2019.

9. <u>To consider Council's response to revisions to application P19/13853/F Mundy Playing Fields</u> Pavilion

328/19. Council considered the revised design. They welcomed a pitched roof but remain concerned about the loss of light and impact on residential amenities. They are not sure why the internal columns are unacceptable as suggested by the architect.

The Clerk reported that due to severe staff shortages on the green out-sites team the Clerk had agreed with the Chair of Playing Fields a price to pay for an external gravedigger to dig two graves. Council approved this course of action and requested we consider these costs in any revisions of fees and charges.
