1. TO RECEIVE ANY APOLOGIES FOR ABSENCE

2. TO RECEIVE ANY MEMBERS' DECLARATIONS OF INTEREST

There were none.

3. TO RECEIVE ANY REPRESENTATIONS FROM THE PUBLIC

There were none present.

4. TO CONSIDER ANY MATTERS ARISING FROM THE REPORT OF THE MEETING HELD ON 21st JANUARY 2020 NOT CONSIDERED ELSEWHERE ON THE AGENDA

The Clerk updated Committee that she had received a response from the Berkeley Hunt, that she had circulated by email. They were seeking to address the issues raise with them and were happy to meet the resident concerned if they so desired.

5. TO CONSIDER ANY MATTERS ARISING FROM THE COUNCILLORS' SURGERIES

Cllr Stansfield reported that a resident from the Park Farm estate had come to raise the issue again that there is no bus service servicing the area. The resident had also found that the four Vale link service does not always turn up and is often late. It was agreed that the South Gloucestershire Councillors would pursue the matter with South Gloucestershire Council about the general issue that there are no buses servicing that part of the town. The Clerk would write to Four Town Vale Link to report that we have received a complaint about the service and ask if they could confirm if the service is running to a timetable?

6. TO CONSIDER COUNCIL'S RESPONSE TO THE FOLLOWING CONSULATIONS:

a) The West of England Combined Authority (WECA) regional Bus Strategy

It was agreed that if any Councillor wished to respond to this they should do so by the 15th March.

b) The West of England Combined Authority (WECA) local cycling and walking infrastructure plan (LCWIP)

The Clerk circulated a response to the consultation that had been written by the Neighbourhood Plan Steering group. It was agreed that as the response was thoroughly comprehensive and the Committee was in agreement with it, the Clerk would endorse the Neighbourhood Plan comments and add that they would like to see a pedestrian crossing installed near Grace Lodge on Rock Street ahead of the proposed one near the Golf Club.

c) South Gloucestershire Council's Planning Committee/ Delegations review

The Committee asked that we respond to seek reassurance that, if a review is controversial or for a large application in Thornbury then the Committee or hearings should be held in the Town, so they are accessible.

The group would have a presence on several of the Saturdays during the period and there has been some good press coverage which is necessary to prove consultation to the inspector.

The Committee considered an email that had been circulated earlier that day from South Gloucestershire Council with reference to consultation about Green Spaces. There were two
