#### 1. To receive any apologies for absence

33/21. None had been received.

#### 2. To receive any member's declarations of interest

34/21. Cllr Parkinson declared an interest in the Over 60's Tea Room, item 17i.

#### 3. To receive any Chairman's announcements

35/21. None.

#### 4. To receive any representations from the public

36/21. Two members of the public had joined the meeting to listen, but neither wished to speak.

# 5. To consider and approve the minutes of the meeting of Thornbury Town Council on 12.01.21 and any matters arising from them

37/21. The Clerk would chase South Glos Council for the next meeting date on the High Street pedestrianisation. Cllr Emmerson proposed the minutes be accepted as a true record, seconded by Cllr Stringer and all were in favour.

#### 6. To receive and approve reports from the following committees and any matters arising from them

#### (a) Environment on 19.01.21

38/21. Cllr Stringer presented the report, highlighting Pullins Green beds issues and hanging baskets. A new member of the committee representing Sustainable Thornbury was welcomed and would replace the former representative of the same organisation. He proposed the report for adoption, seconded by Cllr Rawlinson and all were in favour.

(Cllr Helen Harrison joined the meeting during this item)

#### (b) Playing Fields & Cemetery on 19.01.21

Cllr Parkinson presented the report, explaining that a decision regarding the placement of a shed for the football club had been deferred, owing to the Council needing to review the use of the land for other purposes. He provided an update on the funding for the Chantry play area; the funding body had received a similar proposal from a charity in Almondsbury and they were unwilling to fund both projects. Discussions were now taking place to see if we could work together with the charity in any capacity. The committee had approved quotes for new mowers at the cemetery. He proposed the report for adoption, seconded by Cllr Griffin and all were in favour.

#### (c) Town Development on 26.01.21

40/21. The report was presented by Cllr Tyrrell who stated it had been a short meeting and as many of the items of discussion were also on the agenda for this meeting, she would propose the report for adoption. The proposal was seconded by Cllr Holloway and unanimously adopted.

#### (d) Finance & Policy on 28.01.21

41/21. The report was presented by Cllr Davies. The police had attended and given a helpful report on matters they were dealing with in the town. The Committee had adopted three new policies and approved money needed for cemetery works. They had also looked at the condition surveys for the Council buildings. Cllr Davies proposed the report for adoption, seconded by Cllr Holloway and all were in favour.

#### (e) Staffing on 28.01.21

- 42/21. Cllr Rawlinson presented the report, explaining that the new RFO had recently started. A new grounds person had also started, but unfortunately resigned, having been made a better offer elsewhere. The Clerk and Deputy would approach another candidate from the interview process to try and fill the position.
- 43/21. Staff were responding to unprecedented challenges, the Town Hall was currently closed in line with government legislation, but this would be reviewed soon. The appraisal process continues. Cllr Rawlinson proposed the report for adoption, seconded by Cllr Stringer and unanimously adopted.

#### 7. To consider the following matters related to council finance

#### (a) To approve the accounts for payment

The Clerk clarified two points raised, on the flagpole maintenance costs and strain on the pension fund. The accounts were proposed for payment by Cllr Rawlinson, seconded by Cllr Davies and all were in favour.

# (b) To update on any other financial matters

45/21. The Clerk reported that the new RFO had started recently and was doing well.

#### 8. To receive feedback from Council representatives from groups they attend

- 46/21. Cllr Parkinson had circulated a report on the site at Berkeley and Oldbury Power Station. A bid was being submitted by the end of March, for a fusion reactor to be developed on this site. Cllr Emmerson proposed writing to the power station to support the bid, which was seconded by Cllr Tyrrell and all were in favour.
- 47/21. Cllr Holloway reported that Four Towns and Vale Link had a busy year and this was expected to continue into the next year. Cllr Stansfield had attended an ALCA meeting. Cllr Shipp reported that Thornbury In Bloom had a new Chairman and they were excited for the coming year.

#### 9. To review the Council's

#### a) Standing orders

48/21. The Clerk confirmed the Council's obligations. The Standing Orders were proposed to be accepted by Cllr Emmerson, seconded by Cllr Tyrrell and all were in favour.

#### (b) Financial regulations

49/21. The Financial Regulations were proposed for acceptance by Cllr Rawlinson, seconded by Cllr Davies and unanimously adopted.

#### (c) Risk register

Completing the actions on the condition survey will reduce the risk as it improves health and safety. For this review, the Clerk had based the updates on actions already done and not those in the pipeline. The Risk Register was proposed for acceptance by Cllr Davies, seconded by Cllr Stringer and the majority were in favour, with one abstention.

#### 10. To review the Committee and Outside Body membership and agree any nominated changes

- 51/21. Cllr Murray was proposed by Cllr Tyrrell to join the Town Development Committee. This was seconded by Cllr Bijster and unanimously agreed.
- 52/21. Cllr Stansfield was proposed to join the Youth SLA to fill a vacancy. This was seconded by Cllr Rawlinson and all were in favour.
- The other two vacant positions for the Larger Council's Forum and Transport Forum would be decided at the Council's upcoming AGM, as neither group were currently active.

#### 11. To update on progress of Thornbury Neighbourhood Plan

The Clerk had written to South Glos Council about the consultation delay and had received a response. Cllr Stansfield proposed the Clerk write back again and state that Council expects progress on this matter as soon as COVID allows. Cllr Tyrrell seconded this and all were in favour.

#### 12. To consider planning and licensing applications

55/21. The applications were discussed, and comments made, as per attached schedule.

#### 13. To consider NALC's response to the following consultations:

- i) NALC response to the consultation on the 'Right to Regenerate'
- 56/21. Councillors agreed it was important to reply to this. Cllrs Stansfield, Tyrrell and Davies would form a response.
- ii) South Gloucestershire Council Local Plan 2020 Phase 1 Issues and approaches Consultation
- A draft response had been completed by a working group of Councillors and the Clerk. Councillors felt that a separate category of 'market towns' is needed, as Thornbury should not be considered 'urban'. There was discussion around the nuclear site and it was felt that the land, once no longer needed, should be used for the most environmentally suitable purpose, rather than necessarily the original one. It was agreed that the Clerk would add these comments to the response drafted and then submit to South Glos Council. This response was proposed by Cllr Parkinson, seconded by Cllr Tyrrell and all were in favour.

# 14. <u>To receive information from discussions with South Gloucestershire Council about tackling Climate Change</u>

- The Clerk explained that there were two tools she had looked at, one of which she found more directly useful than the other. She had received advice that all councils were likely to have had a good year last year, in terms of carbon emissions, because many buildings were closed and vehicles were off the road. Cllr Stansfield proposed that Councillors consider the current committee structure to look at how Climate Change can be given greater consideration. This was seconded by Cllr Parkinson and all were in favour.
- 15. <u>To resolve under the Public Bodies (Admission to Meetings) Act 1960, that the public and press be excluded from the meeting during consideration of this item of business as publicity would be prejudicial to the public interest because of the confidential nature of the business to be transacted.</u>
  - 59/21. Resolved.

### 16. To consider and approve actions relating to the Condition survey

- a) Feasibility study and quote
- The Clerk gave the cost and timescales. Cllr Tyrrell proposed to accept the quote, seconded by Cllr Rawlinson and the majority were in favour with one abstention.

(Cllr Griffin left the meeting)

#### 17. To consider leasing issues

- i) To consider a request from a tenant to carry out improvements
- The Over 60's Tea Room had received a grant to fund internal decorating works and requested permission to carry these out. The majority were in favour with one abstention.
- ii) Other works and issues relating to a lease

- 62/21. It was agreed the Clerk would speak to South Glos Council to resolve an issue with rate paying at the Town Hall. All were in favour of this action.
- iii) Change of use for Council property
- 63/21. There would be a tax implication for changing the use of a building from residential to commercial. It was agreed that staff could go ahead with the change of use. All were in favour of this action.

## 18. To consider quotes for the following:

- a) Gas supply for Town Council properties
- 3 green companies had been approached and it was agreed to go with the cheapest rates. The majority were in favour with 1 abstention.
