1. EMERGENCY EVACUATION PROCEDURE

The procedure was outlined.

2. TO CONSIDER ANY APOLOGIES FOR ABSENCE

Apologies were noted from Cllr Guy Rawlinson and Cllr Helen Harrison. Apologies had also been sent by Mr Mike Elcock (St Mary's Churchyard representative).

3. TO RECEIVE ANY MEMBERS DECLARATIONS OF INTEREST

There were no declarations of interest.

4. TO RECEIVE ANY REPRESENTATIONS FROM THE PUBLIC

There was one member of the public present who wished to observe the meeting, but not speak.

5. TO APPROVE THE MINUTES OF THE OPEN SPACES COMMITTEE HELD ON 15.03.22 AND TO RECEIVE AN UPDATE ON ANY OPERATIONAL ISSUES OR MATTERS ARISING FROM THE REPORT NOT CONSIDERED ELSEWHERE ON THE AGENDA

The minutes were approved. An operational update was provided by the Deputy Clerk on the Chantry Road play area, the Streamleaze play area and topple testing at the Cemetery.

Tree Warden's report to the Open Spaces Committee

July 2022

The Tree Council

The Tree Council has been restoring and planting hedges for the past eighteen months, so our Oakleaze hedge planting was very much in line with their initiative which is to fill the gaps in important wildlife corridors. The planting of hedges is also included in the Local Nature Action Plan currently being worked on.

National Hedgerow Week is from 17th – 25th September

I would like the committee to consider another area where we could plant more free trees from the Woodland Trust - either individual trees or another position where a hedge could be planted. Please see below for the planting areas based on the number of trees per pack.

Please note I have over 150 saplings potted up in my garden ready for planting if it is possible to find a position to plant them in November.

Free tree packs

Hedge packs 30 trees: 6 - 8 metres for a double row of hedging

Copse packs 30 trees: size of a tennis court

Woodland packs:

105 trees: size of four tennis courts or 20 - 25 metres of double row hedging

420 trees: size of a football pitch or 85 - 100 metres of double row hedging as

this season's planting

Up to four packs of trees can be ordered to a maximum of 420 trees.

Tree Species 2022

Please see the attached list of tree species planted since 2009, there are multiple numbers of trees in most categories. If it is possible to demonstrate the **interactive database** at some point you will be able to see the emphasis on increasing the variety of trees around Thornbury. Would it be possible to set aside a session for this to take place, please?

Requests for trees for planting during the 2022/3 season

To date there are three requests for memorial trees for planting in the cemetery which have come through Wendy.

I have also received five further requests at the moment, but this will increase as we get towards the autumn. One is for a replacement tree that is dying, and I am waiting for Neil Gazzard to check on the tree and give me permission to plant as it's on S Glos land.

Another is for the United Reform Church who are celebrating their Golden Jubilee on 1st October.

I have also been asked by Thornbury Men's Shed for at least two memorial trees for past members, and possibly a third before too long, for planting on the green off Thicket Walk.

The fifth has specifically been requested for planting in the Chantry Field.

It is important to emphasise that, as the next meeting isn't until September, any plans for planting trees during the next tree planting season which begins in November, needs to be decided at that stage in light of the ecological survey.

The Tree Strategy Group are entering the In Your Neighbourhood Award (IYNA) for the Thornbury in Bloom Judging on 21st July.



Thornbury Town FC - Public Address System Proposal

BACKGROUND - The Mundy Playing Fields has been the home of Thornbury Town Football Club since the end of the Second World War, after many years of a "nomadic" existence, playing on various pitches around the town.

Recent years has seen the Club go from strength to strength and its 18 teams now caters for all ages from under 6 to adult level, including two girls teams. It is estimated that each weekend almost 300 children and adults are involved with the Town's teams.

The Thorns first team in particular has enjoyed a lot of success over the last 6 or 7 years having secured two promotions and two cup final victories, with a team that is primarily made up of local players who have progressed through the junior teams.

The 1st Team now compete in the Uhlsport Hellenic League Premier Division which is Step 5 in the National League System, competing against teams in Gloucestershire, Wiltshire, Oxfordshire and Herefordshire. Effectively we are 5 divisions below the Football League. Home fixtures regularly attract attendances of 100-150 spectators, including visiting supporters for whom this is may well be their first ever trip to Thornbury.

The National League System is operated by the Football Association and they set strict criteria for ground facilities for clubs, depending upon the level at which they are competing. The higher the Step at which the club competes, the more facilities that are required by the FA. Regular "Ground Grading" assessments are carried out to ensure clubs meet those grading requirements and in the event of "non-compliance" it is likely that the club will be automatically relegated to the division below, irrespective of results on the pitch.

In recent seasons, fencing has been installed around the main pitch at the Mundys, along with floodlights and spectator stands. This has all been done with the aid of grants from the Football Foundation and fundraising by the Club, together with the support of the Town Council.

We know that our ground does not currently meet the Ground Grading Requirements for our level of football, as amongst other things we are required to install a Public Address system.

This proposal relates to the installation of a PA System.

PROPOSAL – The installation of a Public Address System at the Mundy Playing Fields for use on match days only, for the benefit of spectators attending the game. The cost of the installation will be met by the Football Club with the benefit of a grant from the Football Foundation.

INSTALLATION – At this stage we have had advice from a local company (Tom Grey of Loud Hire Ltd., who we understand has carried out work for the Town Council in the past) and I can do no better than copy from his report, detailing the work involved:-

Main system objectives...

- 1. To deliver speech announcements clearly across the pitch towards spectator stands.
- 2. To minimise offsite noise (Hard rejection areas being nearest housing)
- 3. To have a reliable and simple system to operate.

We propose to install 2 horn speakers with 20" flares on either side of the club house wall (pitch side) at height. These will be angled slightly away from each other thus achieving good coverage across the pitch and a 'power alley' down the middle towards the grandstand. The speakers are then crucially not in the direction of nearby housing. As mentioned, Horn speakers do not produce low frequencies (cut off at approx

150hz) therefore these speakers will not suffer from omnidirectional low frequency output as other speaker types would.

We propose to locate the mixing amplifier within a rack at height in the bar store cupboard. This would keep it out of reach of being fiddled with as well as not requiring it to be moved about to be set up for each use. In total 2 cables would leave via the external wall. One speaker cable, One balanced cable for the microphone. Cabling would be secured to the walls using standard cable clips. One cable will then drop into the room overlooking the pitch and into a connector box. The other cable will go to a junction box at speaker 1 a link cable will then split out from the junction box to go to speaker number 2.

We would provide you with a Shure microphone with a switch on the side. Whenever announcements are needed to be made the microphone can just be turned on and off accordingly.

This is all analog equipment and standard and 'tried and tested' for this sort of deployment.

Other info..

These speakers will be light grey in colour.

Each speaker will weigh 4.5KG (once 60w drivers are fitted)

The mixer/amplifier is very low power and likely to draw less than 1.5 amps.

Example of type of speaker to be installed:



We are advised that a "fixed" system such as this is the most reliable and practical for our situation and will meet the FA's ground grading requirements.

MATTERS ARISING - I have tried my best to answer any possible queries that may arise, as follows:-

- 1) Planning Considerations. I have been in contact with South Glos Council Planning Department and they have confirmed there are no planning issues arising. I am awaiting a response from the Environmental Protection Dept but am sure that any noise levels will be well within their guidance. I will provide this as soon as I have a reply.
- 2) As detailed above we will be installing 2 loudspeakers and an amplifier which are connected by cable. The loudspeakers will be installed on the outside wall of the pavilion facing the pitch whilst the amplifier will either be in the pavilion club room or the bar store cupboard.
- 3) We understand that the installation can be done in a day, with most of the work being carried out on the outside of the pavilion. Whilst Council staff will need to be on site to let the contractor have access inside the pavilion, I do not believe the work will adversely affect their usual duties. If it is helpful, we could arrange for a club official to be in attendance throughout the work.
- 4) The work does not involve creating a new structure of any kind or any alteration to the existing building, other than installing the two speakers, at a reasonable height, on the front pavilion wall. Associated cabling will be attached to the outside wall using cable clips.

- 5) Running costs of the system are minimal as the equipment is very low power and as mentioned above draws less than 1.5amps. As the PA system will be in use for a limited time only during a game (see below) we do not anticipate that there will be any noticeable difference to electricity charges. There are no other running costs involved and we are told that there is little or no maintenance required once installed. We recognise that if any maintenance/repair of the equipment is required, this is entirely the Club's responsibility.
- 6) Just for clarity, the PA System will be used for match day announcements to improve the game experience for spectators. It will be at a noise level that can be heard within the ground, but not by nearby houses. It may not even "travel" as far as residents using the play equipment in the park. Sound volume will certainly be lower than for, for example, Thornbury Carnival activities. The type of match day announcements being made will be:
 - a. welcoming players, officials and supporters of our visitors
 - b. Player details of both teams and substitutions
 - c. Goal scorers
 - d. Details of forthcoming fixtures
 - e. Details of raffle prize winners in the event of us running a raffle.
 - f. Details of any forthcoming social events within the club.

Importantly, in the unlikely event of some sort of emergency taking place, it will provide us with a means of advising spectators how to exit the ground safely.

All announcements will be made by a Club official and no one else will have access to the microphone and speaker system.

Whilst it is difficult to assess, I would not think that the PA System will be in use for any more than 15 minutes a match.

I trust that I have covered all the questions that the Committee may have and hope that they will be supportive of our request to enable us to proceed with this work as soon as possible.

THORNBURY CEMETERY SCALE OF FEES AND CHARGES – 2022/2023

1. INTERMENT AND EXCLUSIVE RIGHT OF BURIAL

(a) Fees and charges under these headings apply ONLY where the deceased was permanently resident within the boundaries of the town of Thornbury. Any person who had ceased to be a resident during the last three years immediately before their death, because of the necessity to move to a nursing home or hospital will not be charged double fees. If the Council is unable to establish residency then it will be the responsibility of the purchaser to provide the necessary proof.

In all other cases fees and charges are DOUBLE those shown, UNLESS an Exclusive Right of Burial for the grave space or plot in question is already held.

(b) Burials are accepted between the hours of:-

Monday – Thursday Monday – Thursday 10.00 am – 3pm during summer daylight hours 10.00 am – 2pm during winter daylight hours Friday 10.00 am – 11:30am (excluding Public Holidays)

Interment or scattering of cremated remains may be accommodated between the hours of:-

Monday – Thursday 9.30 am – 3:30 pm during summer daylight hours Monday – Thursday 9.30 am – 3:00 pm during winter daylight hours Friday 9.30 am – 12.00 pm (excluding Public Holidays)

Burials outside these hours will be accepted only if a Coroner or Medical Practitioner certifies that immediate interment is necessary in which case an additional fee will apply.

- (c) In cases of grave opening to accommodate another burial, Funeral Directors will be responsible for the removal and reinstatement of existing memorials and these must be removed in time to give staff at least two clear working days to dig and make ready graves for interment.
- (d) Unless interment takes place within 30 minutes of the time arranged an additional fee will be payable.
- (e) Purchase of Exclusive Right of Burial is COMPULSORY unless there is an existing Deed of Grant in respect of the grave space or cremated remains plot in question. Fees include the costs of the issue of the Deed of Grant.

2. MEMORIALS

- (a) Memorials may only be placed on grave spaces in respect of which an Exclusive Right of Burial is held and when the appropriate fee has been paid.
- (b) Memorial designs and inscriptions must be submitted for approval.
- (c) KERB STONES are NOT PERMITTED in certain areas of the Cemetery.
- (d) NO MEMORIALS other than those supplied by Council are permitted in the areas for INTERMENT OF CREMATED REMAINS.
